

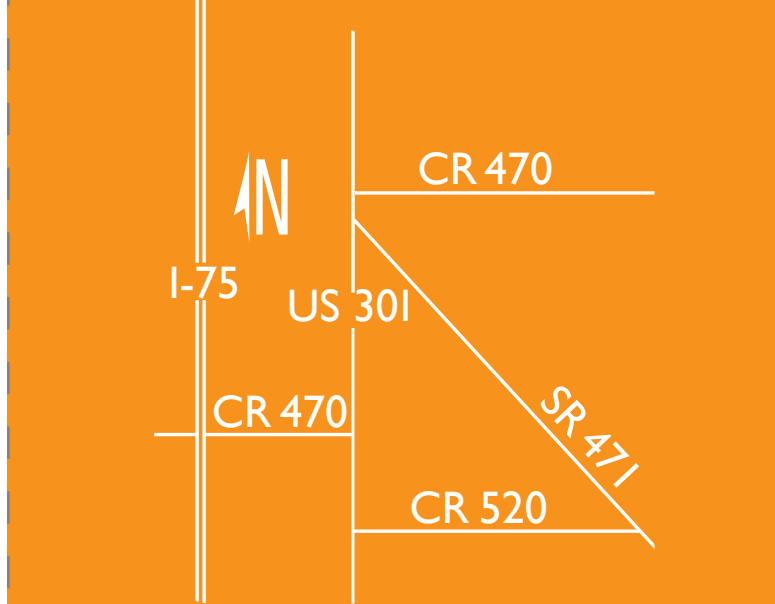

THE ROUTE

If traveling north on US Hwy 301, turn right on CR 520 to park.

If traveling east on CR 470 from I-75, turn right at US Hwy 301 and then make a left turn on CR 520.
