PURPOSE:

To request SECO Energy Board of Trustees' approval to begin consideration of PURPA Standards and approve issuing the Notice of Consideration and Public Notice/Procedural Hearing Process as follows:

Public Hearing/Schedule – Nov 1, 2022 in *SECO News* and SECOEnergy.com Initial Comments – to be submitted beginning April 1, 2023
Reply Comments – to be submitted on or before June 1, 2023
Determination – to be rendered on or before Nov 15, 2023

BACKGROUND:

PURPA is the Public Utility Regulatory Policies Act of 1978. The purpose is the encouragement of investments in conservation and efficient use of facilities by electric utilities and equitable rates to electric customers. Over the years, PURPA has presented new standards for qualified electric utilities to *consider*.

Most recently, the 2021 Infrastructure Investment and Jobs Act (IIJA) requires non-regulated cooperatives (such as SECO Energy), municipal utilities, and state regulators (for regulated utilities) to consider adopting two new standards under Section 111(d) of PURPA. There are two new PURPA 111(d) Standards Under IIJA to consider:

1. Demand-Response Practices

- (A) In General Each electric utility shall promote the use of demand-response and demand flexibility practices by commercial, residential, and industrial consumers to reduce electricity consumption during periods of unusually high demand.
- (B) Rate Recovery
- (i) In General Each State regulatory authority shall consider establishing rate mechanisms allowing an electric utility with respect to which the State regulatory authority has ratemaking authority to timely recover the costs of promoting demand-response and demand flexibility practices in accordance with subparagraph (A).

(ii) Nonregulated Electric Utilities – A nonregulated electric utility may establish rate mechanisms for the timely recovery of the costs of promoting demand-response and demand flexibility practices in accordance with subparagraph (A).

2. Electric vehicle charging programs

Each State shall consider measures to promote greater electrification of the transportation sector, including the establishment of rates that—

- (A) promote affordable and equitable electric vehicle charging options for residential, commercial, and public electric vehicle charging infrastructure;
- (B) improve the customer experience associated with electric vehicle charging, including by reducing charging times for light-, medium-, and heavy-duty vehicles:
- (C) accelerate third-party investment in electric vehicle charging for light-, mediumand heavy-duty vehicles; and
- (D) appropriately recover the marginal costs of delivering electricity to electric vehicles and electric vehicle charging infrastructure.

Determination Process to Consider Adopting new PURPA Standards:

- SECO Energy must consider and make a determination whether to consider or adopt the two new standards.
- PURPA requires a "hearing" process to consider the standard. SECO Energy has
 chosen to engage in a public comment period to consider our members' input on
 the topic. Following direction from NRECA, SECO does not presently intend to
 conduct a live hearing but will, via its comment and response periods, along with
 the opportunity for member attendance at Board meetings where they are allowed
 to be heard on matters affecting the Cooperative, enable our members to be heard
 throughout this process. We plan to facilitate this process through a website form
 based on the schedule below.

SECO proposes the following schedule for compliance:

NOTICE OF PURPA CONSIDERATION AND HEARING PROCESS TO ALL ELIGIBLE PARTICIPANTS

Issued: November 1, 2022

Sumter Electric Cooperative, Inc. (d/b/a SECO Energy or the "Cooperative") hereby gives its members notice regarding the process to be followed in implementing the statutory directives in the 2021 Infrastructure Investment and Jobs Act (2021 Infrastructure Bill), which amended the Public Utilities Regulatory Policies Act of 1978 (PURPA). The 2021 Infrastructure Bill established new Federal standards under Section 111(d) of PURPA, which each non-regulated electric utility (such as SECO Energy) is required to consider and to "make a determination whether or not it is appropriate to implement such standard[s]" within certain defined timelines based on evidence collected from interested persons after public notice and hearing.

A complete public notice issued **November 1, 2022** providing a description of the PURPA amendments and the procedures to be followed by the Cooperative in carrying out the mandate of the 2021 Infrastructure Bill is available on the Cooperative's website at SECOEnergy.com or can be obtained by calling the Cooperative at 352 793 3801. The schedule of key events is as follows:

- ➤ Initial Comments to be submitted on April 1, 2023
- ➤ Reply Comments to be submitted on or before June 1, 2023
- ➤ Determination Announcement by the Cooperative's Board of Trustees to be rendered on or before November 15, 2023
